b) Purpose and duration of data processing.

What is the purpose of your personal data?

Once the initial registration in the currency is made, the client acquires the status of "Registered Client" of Eurocoin. As a client, Eurocoin will process your data for the following purposes:

- Carrying out the administrative procedures proper to their status as client of the entity.
- If you have expressly requested it, send commercial information about news, products and services related to the scope of the New Economy.

After accepting the Eurocoin distribution agreement and making the purchase of its first pack, it will acquire the status of Eurocoin Customer. Together with the purposes indicated above, the customer data will be processed with the following purposes:

- Business management, wallets and Exchange operations in the different sections of the Eurocoin Platform.
- Management of their participation in the different games of the Platform.

How long will the personal data be processed?

Personal data will be kept as long as the contractual relationship with Eurocoin is maintained. Once it is concluded, the data will be blocked during the time for which responsibilities may arise.

c) What is the legitimation for the treatment of the data?

The legal basis for the processing of your data is the execution of this contract.

The legal base for the processing of data for the purpose of receiving commercial information is the consent of the interested party.

d) Recipients of information.

Your Sponsor (Sponsor) will receive in particular the following information: Client number, name, city, state, pack, date of registration, sponsor number and upline number.

International data transfers are not provision.

e) Rights in the processing of data.

Any person has the right to obtain confirmation as to whether Eurocoin Broker is treating personal data concerning them, or not.

The persons concerned can access their personal data, as well as to request the rectification of inaccurate data or, where appropriate, request its deletion when, by other reasons, the data are no longer necessary for the purposes that were collected.

In certain circumstances, those interested may request the limitation of the processing of their data, in which case we will only keep them for the exercise or defense of claims.

In certain circumstances and for reasons related to their particular situation, those interested may oppose the processing of their data.

Eurocoin Broker will no longer treat the data, except for compelling legitimate reasons, or for the exercise or defense of possible claims.
